

Wildlife Lanes Party Terms & Conditions Agreement

The following terms and conditions govern your purchase of party services from Wildlife Lanes. You agree to the following:

- 1. PARTY RESERVATION:** Your reservation is complete upon booking the party through the online reservation system, paying the deposit of \$50.00 by credit card, and submission of the signed Wildlife Lanes Party Terms & Agreement.
- 2. FINAL GUEST COUNT:** Wildlife Lanes will contact the party host three (3) days prior to the party to receive the final attendee and bowler headcount. On the day of the party, adjustments may be made at the discretion of Wildlife Lanes to accommodate guests that are present. Accommodations on the day of the party are not guaranteed and are dependent upon the availability of lanes and/or space at that time.
- 3. FINAL PAYMENT:** Upon arrival, the party host must provide a credit/debit card to open a tab prior to the start of the party. At the end of the party, the payment can be processed on the card provided or that can be paid with cash. The \$50.00 deposit will be applied to the total bill. Credit card transactions are subject to a 4.00% credit card surcharge fee.
- 4. FOOD & BEVERAGE:** All food and beverage consumed at Wildlife Lanes must be purchased through Wildlife Lanes. No outside food or beverage is permitted; this includes bags of chips. The only exceptions to this are cakes and/or cupcakes.
- 5. PARTY TIME & DURATION:** The party host may arrive 20 minutes prior to the reservation time to check in and set up their designated party area. Guests are advised to arrive 10-15 minutes prior to the start of the reservation to get bowling shoes. The party will begin promptly at the time reserved and vacated by the client at the contracted party end time. The two hours of all you can bowl will begin at the scheduled party time, whether guests start bowling at that time or not. The price will not be discounted for a delayed start. Should no guest arrive within the allotted time, Wildlife Lanes reserves the right to release your lanes. To accommodate other scheduled events and parties, lane rentals and space time will not be extended due to late guests or wanting extra time. Extension of the lane reservation is subject to lane availability; the client is responsible for any additional charges. Lane location will be selected at the sole discretion of Wildlife Lanes.
- 6. CANCELLATION/RESCHEDULE:** If the party is cancelled more than seven (7) days before the party reservation date, Wildlife Lanes will refund the deposit. Should the client decide to reschedule the party more than seven (7) days prior to the party, the deposit will be applied to the future party within 90 days of the original schedule date. Any deposit not used within 90 days of the original reservation will be forfeited. If the event is cancelled less than seven (7) days prior to the scheduled party, the deposit is forfeited. The cancellation policy remains in effect regardless of incidents incurred by the client.
- 7. DECORATIONS:** Decorations that hang from the ceiling or on the wall are not permitted. Glitter, confetti, silly string, pinatas, noise makers, and large balloon arches/arrangements with backdrops that require additional space on the concourse are prohibited. Balloons that can be tied to chairs or to balloon weights that can be set on tables are permitted. The client may bring their own table settings such as themed plateware, plasticware, and table clothes.
- 8. GIFTS & PARTY FAVORS:** Gifts and excess party favors must be removed from the premises at the conclusion of the party. Wildlife Lanes is not responsible for the safe keeping of materials, gifts, and belongings left behind after the conclusion of the party.
- 9. INDEMNIFICATION:** The client is responsible for any and all damages, losses, claims, and liability arising out of or related to your guests' use of the party facilities, equipment and services, or related to your event, including property damage or personal injury arising therefrom, and will release, indemnify, and hold Wildlife Lanes harmless from damages, losses, claims, and liability resulting therefrom (other than claims caused by our gross negligence or willful misconduct).
- 10. SAFETY:** Our services and facilities are provided "as is" without any warranty or representation express or implied. Wildlife Lanes is not liable for any consequential, indirect, punitive, special, general, exemplary, economic damages arising from this contract or our services. Our liability, if any, in all cases shall be limited to amounts paid to us under this agreement.

Your party may involve physical activity. You and your guests represent that you are in proper health to participate in such activities. You assume risks arising therefrom. We reserve the right to refuse service and remove anyone from the premises which we reasonably believe threatens the safety of personnel or guests or causes damage to our facilities, including activity pertaining to: concealed weapons, intoxication, dress code violations, health/security, illegal drug activity, and/or any activity that violates federal, state, or local laws. Other local restrictions and facility house rules apply.

The following safety policies must be adhered to:

- All guests who participate in bowling are required to wear bowling shoes.
- The side aisles next to the end lanes are restricted to Wildlife Lanes staff. No picture taking is to occur past the foul line or in the side aisles.
- Only one person is to be on the lane at a time, excluding an adult assisting a child.
- Wait for the bowling ball to stop rolling on the ball return before retrieving or replacing bowling balls. Do not reach into the ball return opening as moving parts will cause serious injury.
- Always ask an associate for assistance with anything that may cause injury or interrupt gameplay such as a misplaced pin, a spilled beverage, or a ball that has not made it down the lane.
- Guests are prohibited from sitting on bowling ramps or sliding down them.
- Refrain from excessive noise, use appropriate language, respect other bowlers' turns. Roughhousing, running, or any behavior that could pose a safety risk or disrupt other customers' experiences is strictly prohibited. Violators will be asked to leave the facility without refund after one violation.
- Bumper rails must be raised and lowered solely by a Wildlife Lanes employee. Note the warning stickers on the bumper rails and do not touch them at any time to avoid injury. Raising or lowering bumper rails may result in violators being asked to leave without refund
- Guests are prohibited from walking on the bowling lanes at any time or any reason; doing so may result in serious injury and/or dismissal of that guest and/or termination of your lane(s)
- Remain standing when throwing the bowling ball. Intentionally falling, spinning, throwing, or actions that may cause injury to yourself or others is prohibited.
- Please walk; running is prohibited in the bowling center at all times.
- Guests are to stay on their assigned lanes as to respect others on neighboring lanes.
- The party host is responsible for all guests' behaviors and actions; **one adult is required on each lane to supervise children at all times.**

11. FORCE MAJEURE: Wildlife Lanes is not liable for delays, postponements, or other circumstances beyond its control including but not limited to an act of God, the unavailability of lanes, loss of utilities, inclement weather, scheduling, fire, earthquake, unusual transportation delays, material or labor restrictions by any governmental authority, strikes, lockouts, sit-downs, riots, explosions, acts of the public enemy, war, and insurrections.

12. REPRESENTATIONS: Each party represents and warrants that (i) it has full power, authority, and legal right to execute, deliver and perform this Contract, (ii) the execution, delivery, and performance has been duly authorized by all necessary corporate action, and (iii) the execution, delivery, and performance of this contract will not cause it to be in breach or default of any contract to which it is a party.

13. ENTIRE AGREEMENT: This Contract shall not be assignable by Customer without prior written approval of Wildlife Lanes, in its sole discretion. Any such assignment without Wildlife Lanes's prior written approval shall be void.
